Notice regarding Resignation / Withdrawl of allotted seat from Round-1
Counselling and Online Counselling Programme for Round-2

In continuation to Adv. No. BCECEB(UGMAC)-2026/03 dated 25.08.2026 & 2026/04 dated 31.08.2026, it is informed to all eligible & interested NEET(UG)-2026 qualified candidates and all concerned that as per Health Department, Bihar, Patna Letter no. 1246(1) dated 10.09.2026, 2 (Two) New Govt. Medical Colleges viz. (i) Sriram Janki Medical College & Hospital, Samastipur (ii) Govt. Medical College, Chapra (Saran), 1 (One) Pvt. Medical Colleges viz. Kurma Sanskriti Medical College & Hospital, Kurma, Jehanabad and some additional seats in different Private Medical Colleges has been added.

2. In the light of above, updated seat matrix has been uploaded on Board's website.
3. Therefore, Online Registration & submission of Application-cum-Choice Filling are invited from qualified, eligible & interested NEET(UG)-2026 candidates who have not duly submitted their Application vide Adv. No. BCECEB(UGMAC)-2026/01 & 2026/02 dated 07.08.2026 for appearing in the Under Graduate Medical Admission Counselling (UGMAC)-2026 in order to select candidates for admission to the first year UG Medical / Dental Courses (MBBS / BDS) in Government/ Private Medical / Dental Colleges of Bihar State and B.V.Sc. & A.H. / B.F.Sc. Courses in Govt. Veterinary / Fisheries Colleges of Bihar based on the Merit-list / Rank of UGMAC-2026 prepared on the basis of merit list of NEET(UG)-2026 conducted by the National Testing Agency (NTA).
4. Due to Upgradation of Round-1 candidate or Resignation of allotted seat by candidate in Round-1 Counselling, virtual vacancy may arises for Round-2 Counselling. So, candidates eligible for Round-2 Counselling may do choice filling / Edit their choices by keeping this fact in their mind.
5. All Freeze candidates of Round-1 Counselling will have to give their consent for participating in Round-2 Counselling by login to their account with their NEET(UG)-2026 Roll No. & Password by clicking the link "Online Portal of UGMAC-2026" available on Board's Website.
6. All Freeze & Float candidates of Round-1 Counselling may edit their previous filled choices for Round-2 Counselling but can not remove / delete their Round-1 Counselling allotted choice from the choice list. The candidates will have the facility to swap the positioning of their Round-1 Counselling allotted choice. Such candidates will not have the facility to edit their Application Form data.
7. All Freeze candidates of Round-1 Counselling who have successfully completed their document verification process without any discrepancy and has taken admission but not taken Resignation / Withdrawl within scheduled period as well as not given their consent for participating in Round-2 Counselling will be treated as admitted candidate.
8. The Float candidates of Round-1 Counselling, who do not edit their previous filled choices, their seat allotment process for Round-2 Counselling will be done on previous filled choices only.
9. All Freeze candidates who will take Resignation from their Round-1 allotted seat or Float candidates who will withdraw their Round-1 allotted seat within scheduled period as mentioned in the "Important Dates" or who have been treated as Free-Exit, if wants to participate for Round-2 Counselling will have to login to their account with their NEET(UG)-2026 Roll No. & Password by clicking the link "Online Portal of UGMAC-2026" available on Board's website and will have to fill fresh choices as their previous choices will become "Null & Void" else they will not be eligible for Round-2 Counselling seat allotment process.

If such candidates wants to edit their Application Form data, then they will have the facility to edit their Application Form data.

10. All such candidates who have not been allotted any seat through Round-1 Counselling may also edit their previous filled choices. Such candidates will also have the facility to edit their Application Form data.

11. If candidate wants to edit their previous filled Application form Data, he / she is advised to see the section "Editing / Correction of Application Form Data" of Adv. No. BCECEB(UGMAC)-2026/01 dated 07.08.2026.

12. Due to Editing / Correction of data, if any additional Fee payment condition arises then candidate will have to re-pay the desired full-fee of Counselling Fee & Security Deposit afresh and ensure the payment. Such candidate's previously paid amount of Counselling Fee & Security Deposit will be refunded back to their account through the same mode by which they had done the payment.

13. Consent will be authenticated through Login password and OTP sent on their registered Mobile No. / Email ID.

14. During Editing / Correction of Application Form data, candidate will not be allowed to edit their data like Name, Father's Name, Mother's Name, Date of Birth, Gender, DQ, Mobile No., Email ID, Proof of Identity and Identity No. etc.
